**SUPERINTENDENT’S REMARKS**

Superintendent Lee greeted everyone. He informed everyone that the District is close to completing the Reopening Plan; it should be complete next week. He said the District is making every effort to include the community’s input for the Reopening Plan. A parent survey was completed to see how many parents were interested in remote learning; majority of the parents prefer remote learning.

**PUBLIC PARTICIPATION**

Ms. Marizol Tirado, Vice President, Trenton Educational Secretaries Association (TESA), stated that TESA members are not comfortable returning to their buildings as they do not feel proper precautions have not been completed to ensure their health and safety. Security Officers said they were not informed about the monitors or temperature taking. In addition, they were not trained for COVID.

**Remarks Corrected:** Ms. Judy Martinez, TESA President, asked that the secretary position for Daylight/Twilight be *pulled* as that position has been vacant since *November*. Ms. Martinez said she had a conversation with Mr. Rolle regarding safety provisions at the school. She said Mr. Rolle stated that if the secretary feels the provisions are not accommodating, they can opt to work at home. In addition, Mr. Rolle said if the supervisors had any questions, they were to contact Mr. Rolle. However, the secretaries that opted to work remotely was docked in their July 15<sup>th</sup> pay with no warning. Ms. Martinez feels since the information was not provided to the supervisors, it caused a hostile environment for the secretaries. Ms. Martinez also said the secretaries should be provided with proper equipment to do their jobs remotely i.e. printers, scanners, etc.

Ms. Estella Harris, TESA Secretary, said when Superintendent Lee sent an email stating that employees are to return to work July 6<sup>th</sup>, there was not enough time for secretaries that have medical issues to obtain a doctor’s note. However, secretaries continued to work remotely instead of coming to work on assigned days. It was her understanding that Mr. Rolle was going to handle this matter. However, she was docked in pay. She also questions why the District would not charge secretaries their sick days versus docking their pay as this caused a financial hardship for them.

Ms. Danita Bell, TESA Secretary, addressed the online registration process. She feels the program is not functional. She stated the secretaries as well as the parents are continuously experiencing difficulties.

Ms. Susan Nardi, NJEA Representative, said that the Human Resources Department (HR) takes months to respond to requests for workplace accommodations for medical reasons. While the employee is waiting for a decision from HR, they are working without accommodations. Ms. Nardi stated she was in communication with Mr. Rolle and informed him she would provide a list of secretaries with medical issues. Ms. Nardi said she repeatedly asked Mr. Rolle what the process is in the District. She expressed her disappointment with the District as she has been trying to form a coalition.

Ms. Talitheia R. Duncan, President, Trenton Education Association (TEA), said there are several items in the Reopening Plan that are negotiable items. However, many of the items were not negotiated. Ms. Duncan asked that Curriculum Items C and H be pulled. In addition, she asked that Item N from the HR Agenda be pulled also because it was not fully agreed upon by TEA.

Ms. Naomi Johnson-Lafleur, Negotiations Chair, TEA, told the Board members they are here to serve the community; Legal Counsel should not have advised them not to have a follow up question. Ms. Lafleur stated that she is waiting for a response from the last two Board Meetings regarding negotiable items, to no avail.

Ms. Janice Williams, TEA Grievance Chair, said the reopening of schools is a local issue and that Trenton is unique and should not be compared to surrounding Districts in Mercer County. She said percentages show that the community prefers remote learning. Ms. Williams also said that the District did not follow the terms and agreement of the teachers for the summer program. Ms. Williams also reiterated that the District should not be using someone's personal Facebook page to livestream meetings, as the Technology team is paid well.

**BOARD MEMBER COMMENTS**

Mr. Truehart acknowledged that 77% of the community wishes to have remote learning. He said he is concerned with ventilation considering the age of the District's buildings. He witnessed students at the high school graduation not wearing masks, which broadens his concern for students to return to school at this time. He also stated that response time and communication must be improved with bargaining units.

Ms. Williams feels that a soft opening and piloting teacher training as early as possible should be done. Ms. Williams suggests creating a policy on how to communicate with the public.

Ms. Marrero-Lopez stated she was pleased that the Governor changed his position for kids to return to school. It is her hope that there will be interactive learning for students as she was disappointed to learn this was not being done.

Ms. Brossoie added that it is unacceptable that HR is not processing accommodation requests in a timely manner. Additional information needs to be provided as to how they are being processed and the cause of the delay.

Mr. Bouie agrees that response time needs to improve.

Ms. Daniels-Lane acknowledged all the concerns. She stated that the District is following the Governor's guidelines; and if there is something the District does not agree with, there needs to be push back. It must be put in writing. She said Trenton is unique and in a partnership in Mercer County with other districts; however, each district has its own characteristics.
