NOTICE IS HEREBY GIVEN THAT sealed bids will be received by the Trenton Public School District, Mercer County, New Jersey for Trenton Public School, Trenton, New Jersey, together with all work incidentals thereof, in accordance with the requirements of the plans and specifications.

Given the ongoing emergency declarations related to COVID-19 and to ensure "social distancing" amongst all parties, the District is eliminating the group gathering for the bid opening. Instead, the bid opening will be streamed live using Zoom. All potential bidders are to visit the board of education website and click on bid number and proposal pertaining to the Opening of Bids via Zoom Online Live Streaming.

Bids shall be uploaded to the Districts website by 10:00 am, Wednesday, January 20, 2021 and will be officially opened and read at a Zoom Bid Opening at 1:00 pm, Wednesday, January 20, 2021. **(Prevailing Time).**

The A/E will respond no later than **January 11, 2021, 4:00 p.m.** No bid packages will be mailed. **The Non-mandatory Pre-bid meeting will be held at the project site, 400 Chambers Street, Trenton, New Jersey, on December 16, 2020. We will meet outside in the main parking lot.** All contractors must sign in at the site no later than **9:00 am.** All contractors are required to park in legal, off-site parking spaces.

Bids must be submitted on standard proposal form in the manner designated therein and required by the specifications. A Certified Check, Cashier Check or Bid Bond drawn to the order of the Board of Education for no less than ten percent (10%) of the amount of the bid, but in no case in excess of \$20,000 and addressed to the Trenton Board of Education, 108 North Clinton Avenue, Trenton, New Jersey 08610, Attn: Georgette H. Bowman (Purchasing). Bids must be uploaded to the Board of Education website on or before the time and date stated above.

No bidder may withdraw his bid for a period of sixty (60) days after the date set for the opening thereof. Bidders are required to comply with all the requirements of Affirmative Action Regulations P.L. 1975 and the Prevailing Wage Law as required under chapter 150 of the laws of 1963, State of NJ. The Board of Education reserves the right to reject any or all bids or to accept the bid which in its judgment will be for the best interest of the City of Trenton Public Schools.

Bidding shall be in conformance with the applicable requirements of N.J.S.A. 18A:18A-1 et seq., pertaining to the "Public School Contracts Law". Bidders are required to comply with the Affirmative Action Regulation of P.L. 1975, c. 127, (N.J.A.C. 17-27).

Chapter 33, Laws of 1977 (Assembly Bill No. 22, 1976, approved March 8, 1977)-requires corporate bidders of State, County, Municipal of School contracts to submit a list of the names and addresses of all stockholders owning 10% or more of their stock.
