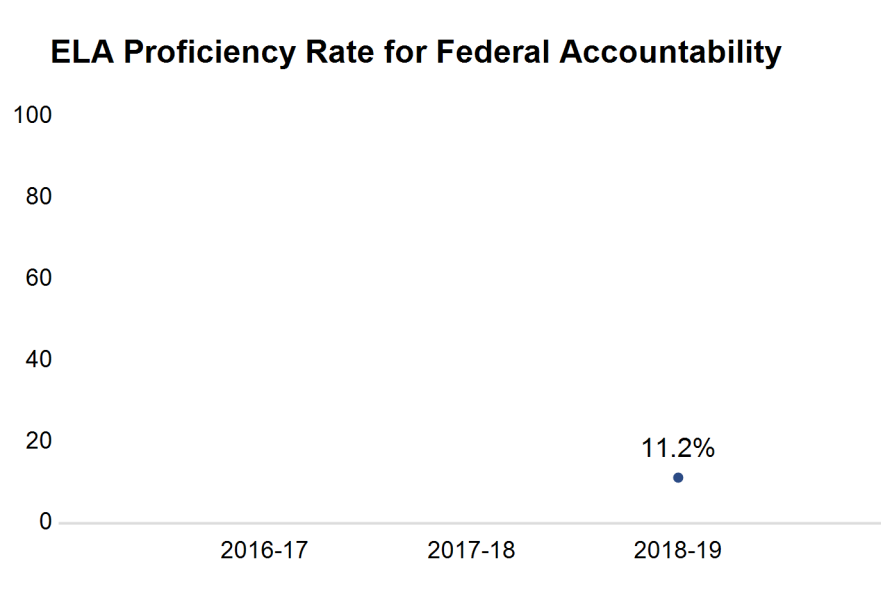

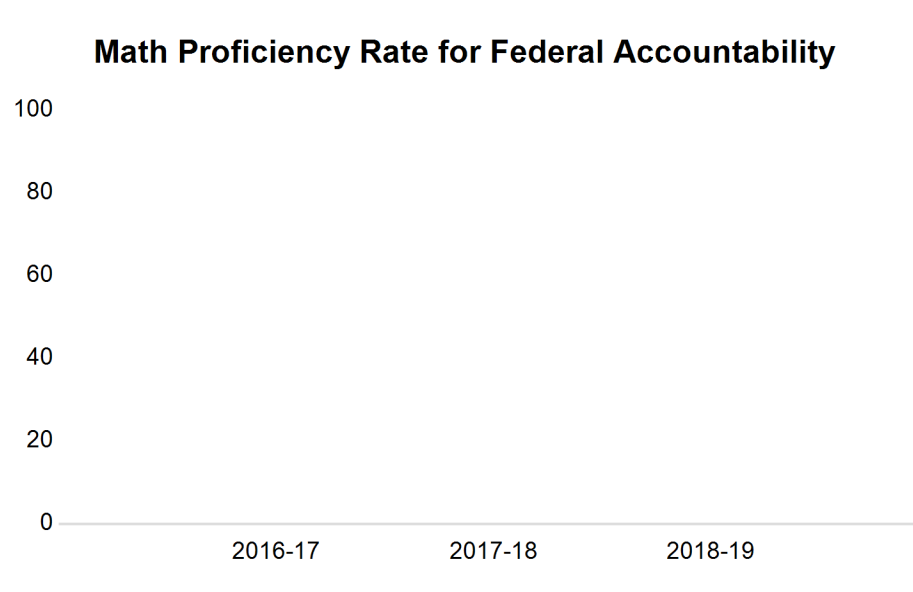
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the statewide assessment (NJSLA for 2018-19 and PARCC for 2016-17 and 2017-18) and the DLM alternate assessment. The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 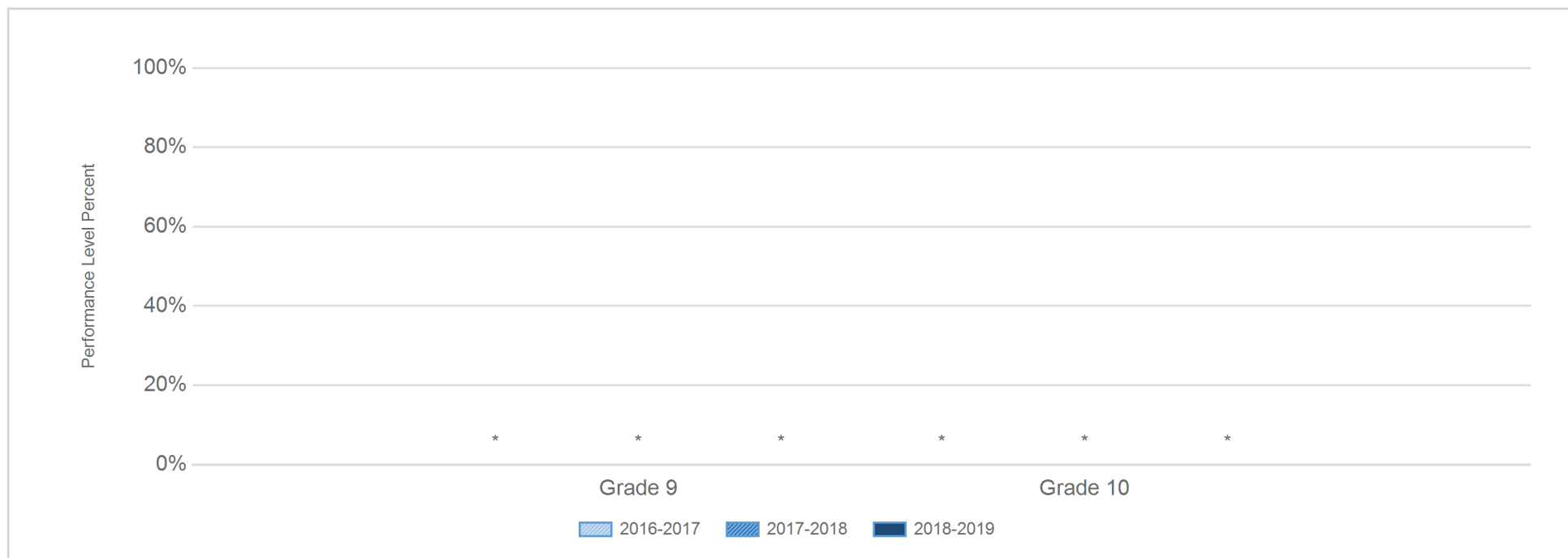

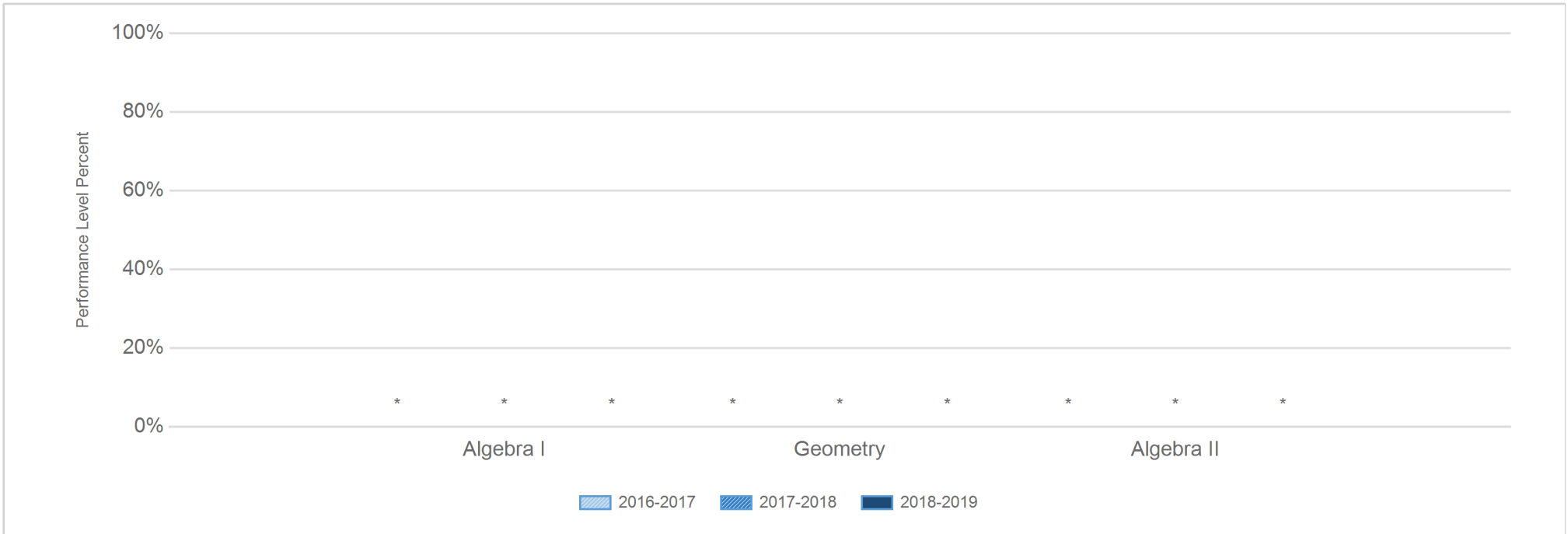

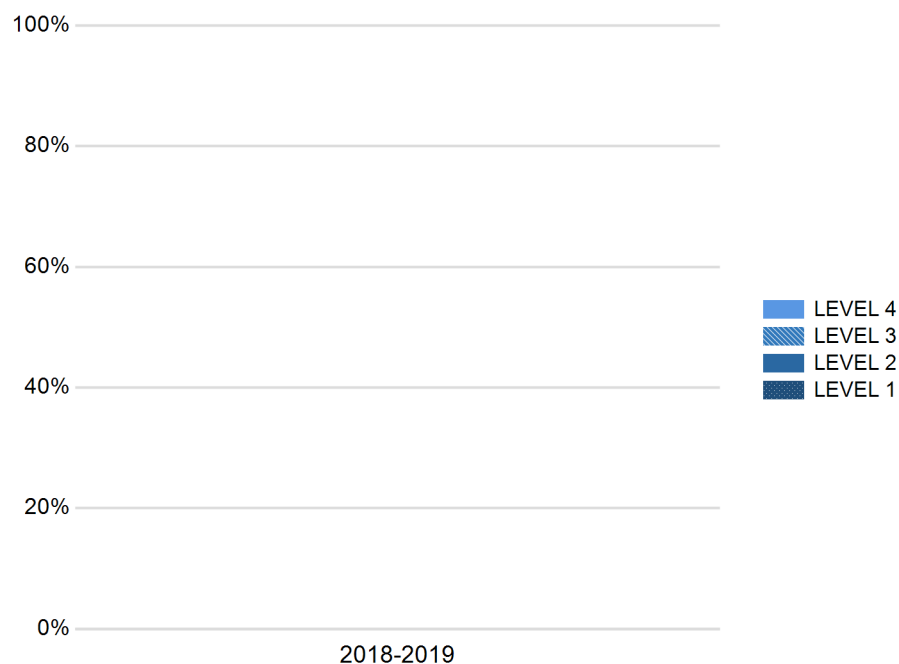

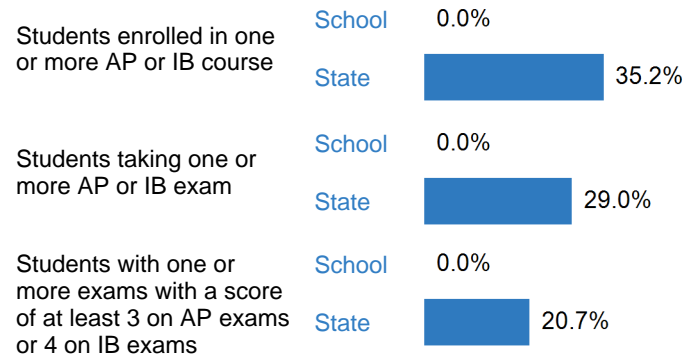

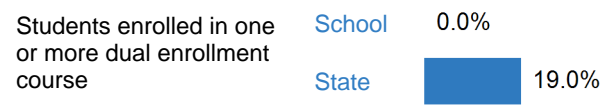

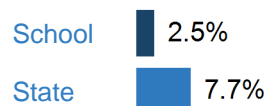

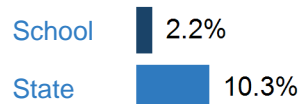

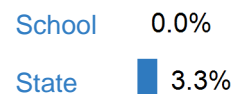

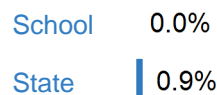

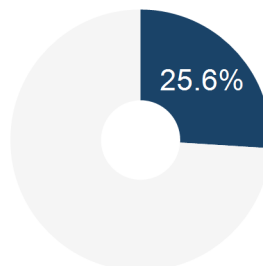

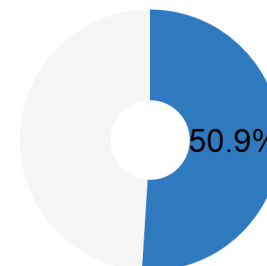

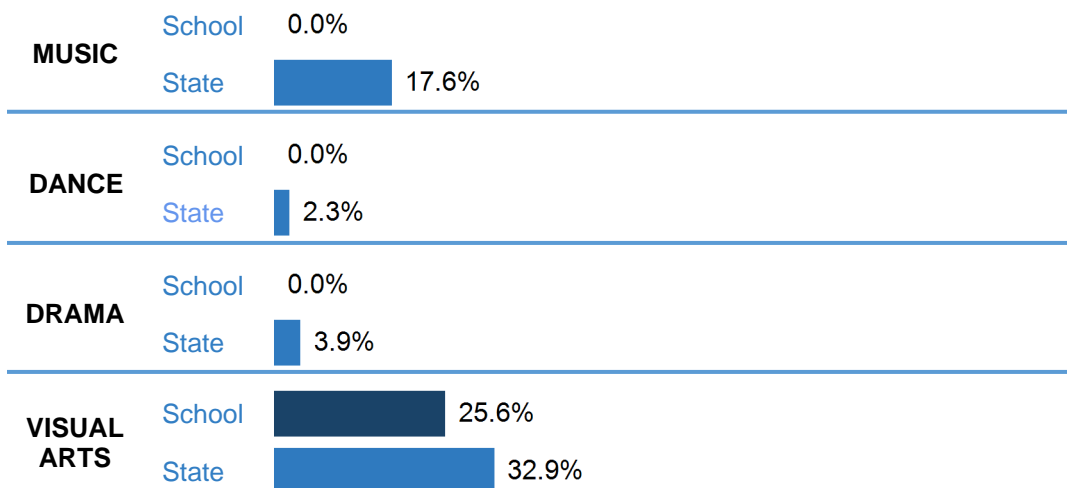

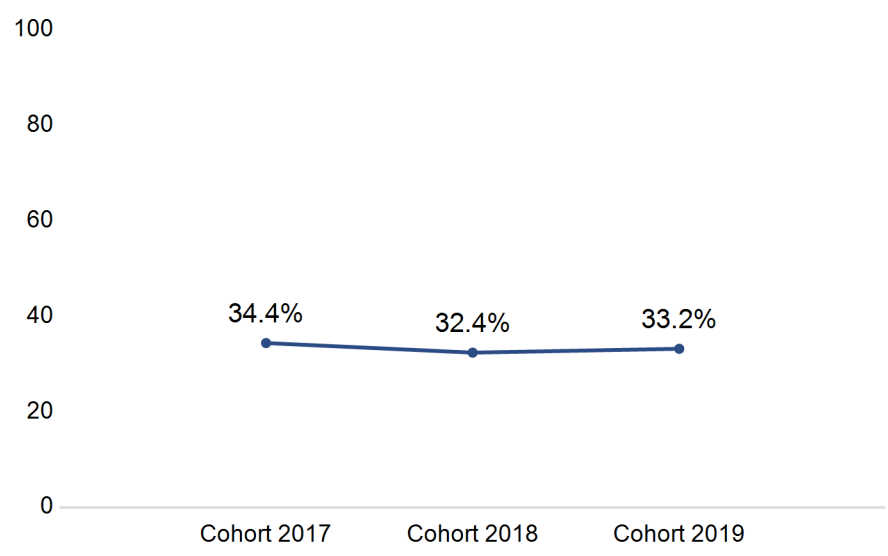

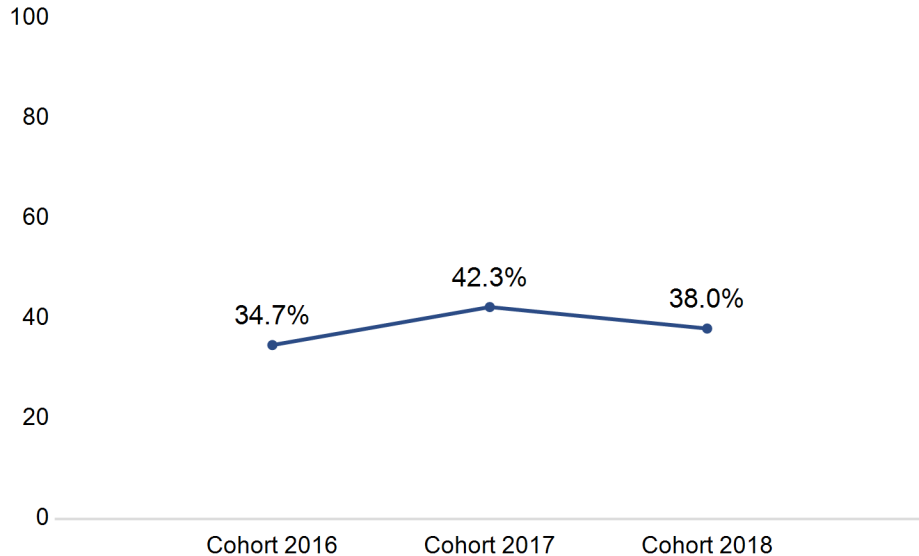

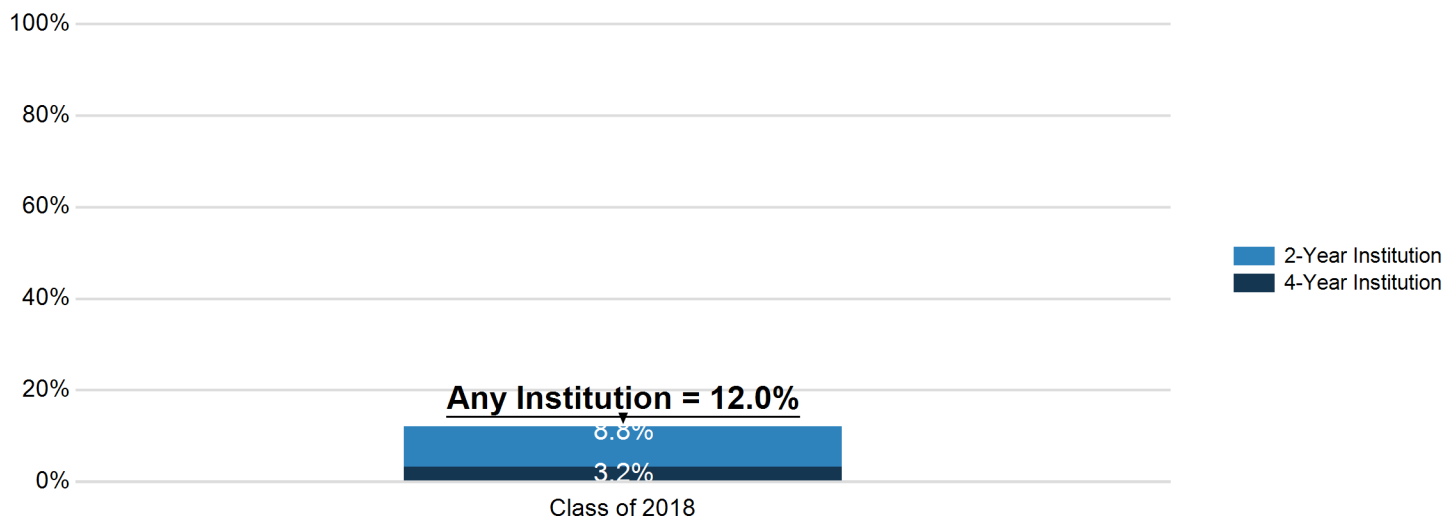

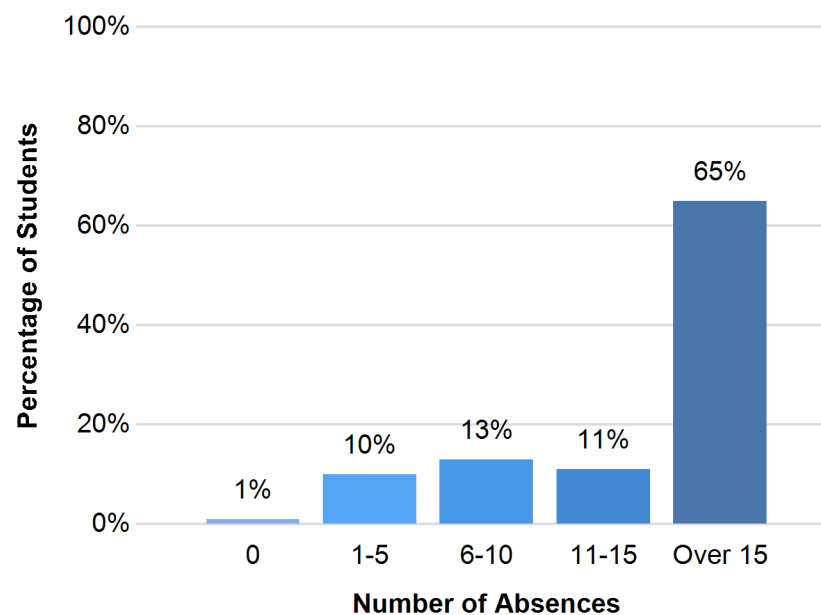

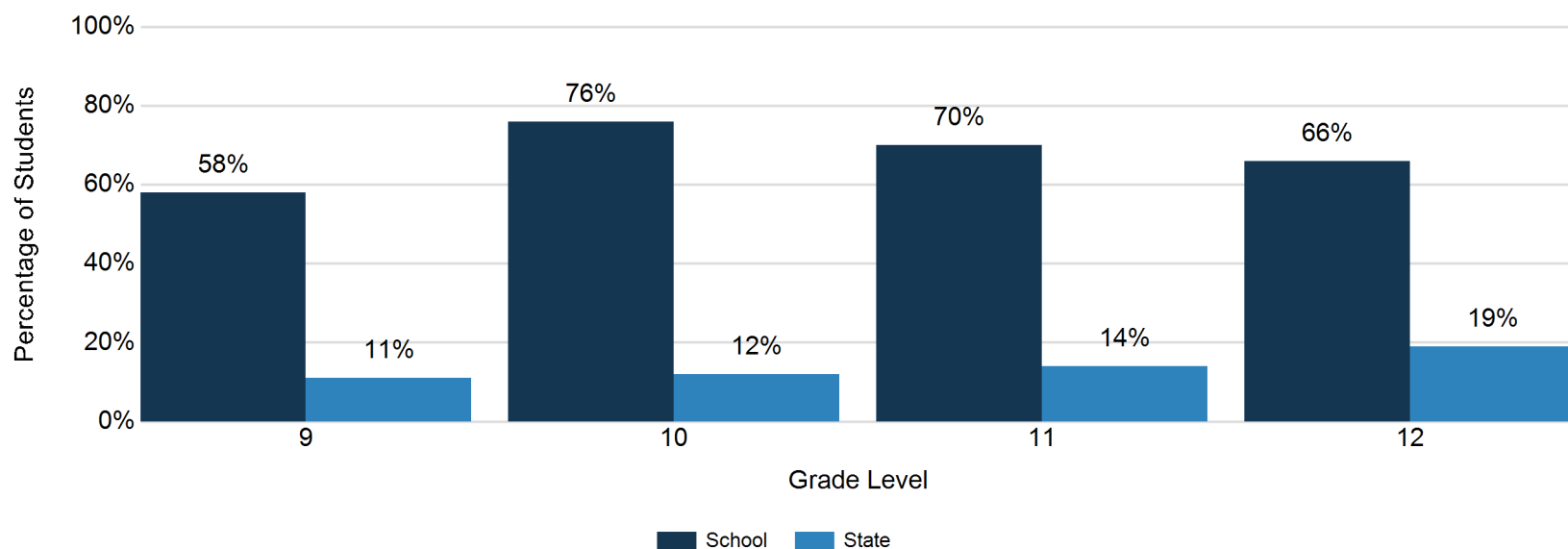

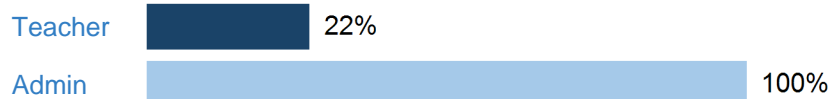

Academically, DTHS operates on a trimester block schedule. Students can take nine courses (45 credits) a year; 3 classes each trimester. Each instructional block is 120 minutes in length. Included in the 120 credit graduation requirement are 4 courses in English, 3 courses in science, 4 courses of PE/health, 3 courses in social studies, 3 courses in math, 1 course in a world language, 1 course in visual and performing arts, 1 course in career ed., and 1 course in financial literacy.
